Attendance: You are expected to attend all classes.

Calculators: Basic scientific calculators are allowed. Calculators with graphing capabilities will *not* be allowed during exams.

Homework: Homework will be assigned every week and it will be partly graded and returned to you. You are welcome (and encouraged) to work in small groups, but each student is required to turn in his or her own written solution. Homework is due at the beginning of class. Late homework will *not* be accepted under any circumstances.

Grading scheme: Grades will be assigned by weighting your totals from homeworks, three exams, and the final exam as follows:
